## Storm Chasers Jingle Contest

# OFFICIAL RULES UPDATED: November 16, 2020

## NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCE OF WINNING.

### 1. HOW TO ENTER

- a. These rules govern Storm Chasers Jingle Contest (the "Promotion") being conducted by Omaha Storm Chasers (OSC) on Thursday, November 19, 2020 at 9AM CST and ending on Sunday, January 8, 2021 at 11:59PM CST.
- b. To participate in the Promotion, you may enter via the following method(s):
  - To participate in the Promotion, you may log onto <a href="https://www.omahastormchasers.com">www.omahastormchasers.com</a> and follow the links and instructions to enter the Promotion and submit your first and last name, complete address, city, state, zip code, telephone number, date of birth and a valid email address. All jingle submissions must include a 15 second and 30 second version of the jingle. Only one internet entry per person and one internet entry per email address is permitted. Final date and time for submissions will be on Friday, January 8th at 11:59PM CST. Internet entries will be deemed made by the authorized account holder of the email address submitted at the time of entry. The authorized account holder is the natural person who is assigned to the email address by an internet access provider, online service provider or other organization that is responsible for assigning an email address or the domain associated with the submitted email address. Multiple participants are not permitted to share the same email address. Entries submitted will not be acknowledged or returned. Use of any device to automate entry is prohibited. It is free to submit an entry for this contest. Proof of submission of an entry shall not be deemed proof of receipt by OSC. OSC's computer is the official time keeping device for the Promotion. OSC is not responsible for entries not received due to difficulty accessing the internet, service outage or delays, computer difficulties or other technological problems.
- c. Limit to one winner.

## 2. ELIGIBILITY RESTRICTIONS

a. The Promotion is open to all persons who are 18 years of age. Employees of OSC, its subsidiary and affiliated entities, OSC's advertising and promotional agencies, its participating sponsors, other radio stations in

the Greater Omaha or Lincoln NE metropolitan area and the members of their immediate families (spouse, parents, siblings, or children) and/or households (whether related or not) are ineligible to participate or win. This Promotion is subject to all applicable federal, state and local laws and regulations and is void where prohibited.

- b. The winner must provide valid government-issued photo identification and provide his or her complete address, date of birth and phone number to claim the prize.
- c. Entrants are required to provide truthful information and OSC will reject and delete any entry that it discovers to be false or fraudulent. OSC will disqualify any entry from individuals who do not meet the eligibility requirements.

#### 3. PRIZES

- a. (1) prize will be awarded in this Promotion. The prize consists of the following:
  - Cash prize of \$2021
  - (1) Chasers Blue Book

The winning jingle will be the official Omaha Storm Chasers jingle for the 2021 season.

The Approximate Retail Value ("ARV") of the prize is \$ 2591. The winner will be solely responsible for all taxes and all other fees and expenses not specified herein associated with the receipt and use of the Prize.

#### 4. WINNER SELECTION AND NOTIFICATION

- a. Decisions of OSC management with respect to the Promotion are final.
- b. The winner will be selected by January 29<sup>th,</sup> 2021. Participants will submit two (2) Omaha Storm Chasers themed jingle (15 seconds and 30 seconds length max) in the online entry form. The winning entry will be selected based on creativity, memorability, and use of Chasers Family. Final date and time for submissions will be on Friday, January 8, 2021 at 11:59PM CST.
- c. The winner must execute and return any required affidavit of eligibility and/or liability/publicity release within ten (10) days of winning or prize will be forfeited and an alternate winner may be selected. If a potential winner cannot be contacted, fails to sign and return the required affidavit of eligibility and/or liability/publicity release within the required time period, the potential winner forfeits the prize.

### 5. CONDITIONS

a. Payments of all federal, state and local taxes are solely the responsibility of the winner. The winner will be required to complete and submit an IRS Form W-9 with the winner's full Social Security Number or the equivalent for receipt of any prize valued at \$600 or more or for any prizes awarded by OSC in a calendar year with an aggregate value of \$600 or more. Failure to submit a complete W-9 or equivalent will result in forfeiture of the prize. Such winnings of \$600 or more will be reported to the IRS.

- b. By participating in the Promotion, the winner agrees to have the winner's name, voice and likeness used in any advertising or broadcasting material relating to the Promotion without additional financial or other compensation, and, where legal, to sign a publicity release confirming such consent prior to acceptance of the prize.
- c. Prior to awarding any prize(s) or prize certificate(s), OSC, in its sole discretion, may require Promotion winner(s) (and any travel companion(s) or guest(s)) to sign a liability release, agreeing to release and hold harmless OSC, its subsidiary and affiliated entities, their respective officers, shareholders, directors, employees, agents and representatives and all of their successors and assigns from and against any and all claims or liability arising directly or indirectly from the prize and participation in the Promotion.
- d. If for any reason this Promotion cannot be executed as planned, including, but not limited to, as a result of infection by computer virus, tampering, unauthorized intervention, fraud, technical failures, or any other causes beyond the control of OSC that corrupt or affect the security, administration, fairness, integrity or proper conduct of the Promotion, or if the Promotion is compromised or becomes technically corrupted in any way, electronically or otherwise, the organization reserves the right to cancel, terminate, suspend, or modify the Promotion. If the Promotion is terminated before the original end date, OSC reserves the right to select the winner(s) by random drawing from among all eligible non-suspect entries received as of the termination time/date or otherwise modify the procedure for selecting winner(s).
- e. OSC, in its sole discretion, reserves the right to disqualify any person tampering with the entry process or the operation of OSC's website. Failure to comply with the rules of the Promotion may result in a contestant's disqualification and/or forfeiture of any prize or prizes. If OSC makes a good faith determination that an entrant has cheated or committed fraudulent activity in connection with a Promotion, OSC reserves the right to disqualify that entrant from entering and/or winning future Promotions and to prosecute and seek damages to the fullest extent permitted by law.
- f. OSC reserves the right to make changes in the rules of the Promotion, including, without limitation, the substitution of a prize of equivalent value, which will become effective upon announcement. If due to circumstances beyond the control of OSC, any competition or prize-related event or travel is delayed, rescheduled, postponed or cancelled, OSC reserves the right, but not the obligation, to cancel, terminate, suspend, or modify the Promotion and shall not be required to award a substitute prize.
- g. OSC is not responsible for typographical or other errors in the printing, the offering or the administration of the Promotion or in the announcement of a prize.
