FOR NON-BASEBALL EVENTS AT FRAWLEY STADIUM

ALL GUIDANCE PROVIDED BY DELAWARE HEALTH AND SOCIAL SERVICES
DIVISION OF PUBLIC HEALTH IN ACCORDANCE WITH CDC GUIDELINES

PER GOVERNOR JOHN CARNEY & DELAWARE HEALTH AND SOCIAL SERVICES DIVISION OF PUBLIC HEALTH, RECREATIONAL & COMPETITIVE BASEBALL/SOFTBALL AS WELL AS OTHER OUTDOOR EVENTS WERE PERMITTED TO RESUME IN THE FIRST STATE EFFECTIVE MONDAY, JUNE 15, 2020 PROVIDED THAT ALL GUIDELINES WITH RESPECT TO SOCIAL DISTANCING AND COVID-19 SAFETY BE OBSERVED. THE WILMINGTON BLUE ROCKS ARE COMMITTED TO PROVIDING A SAFE AND ENJOYABLE EXPERIENCE FOR ALL AND WILL FOLLOW ALL COVID-19 GUIDELINES MANDATED BY THE STATE OF DELAWARE. PLEASE BE AWARE THAT PROTOCOLS MAY CHANGE WITHOUT PRIOR NOTICE DUE TO THE COURSE OF THE PANDEMIC.

GENERAL GUIDELINES & REGULATIONS FOR FRAWLEY STADIUM EVENTS:

1. HAND WASHING – ALL ATTENDEES WILL BE URGED TO WASH THEIR HANDS WITH SOAP AND WATER AS MUCH AS POSSIBLE DURING THEIR TIME AT FRAWLEY STADIUM. FURTHER, HAND SANITIZING STATIONS WILL BE PLACED THROUGHOUT THE FACILITY.

2. SOCIAL DISTANCING – ANYONE ENTERING FRAWLEY STADIUM WILL BE REQUIRED TO MAINTAIN AT LEAST 6 FEET BETWEEN THEMSELVES AND OTHERS WHENEVER FEASIBLE.

3. FACE COVERINGS – ANYONE OVER THE AGE OF 12 THAT ENTERS FRAWLEY MUST WEAR A FACE COVERING IN ACCORDANCE WITH STATE MANDATES. FACE COVERINGS MAY BE REMOVED ONCE FANS ARE SEATED, AS LONG AS THEY ARE ABLE TO CONSISTENTLY MAINTAIN 6 FEET OF SOCIAL DISTANCE FROM ANYONE OUTSIDE THEIR IMMEDIATE HOUSEHOLD.

4. CLEANING & DISINFECTING – ALL ATTENDEES WILL BE URGED TO DISPOSE OF ALL TRASH IN THE DESIGNATED RECEPTACLES. SEVERAL TIMES THROUGHOUT EACH EVENT, AN EPA LIST 6 APPROVED DISINFECTANT WILL BE USED IN ALL RESTROOMS AND ON FREQUENTLY TOUCHED SURFACES.

5. HEALTH MONITORING – ANYONE ATTEMPTING TO ENTER FRAWLEY STADIUM MAY BE SUBJECT TO A TEMPERATURE CHECK AND HEALTH QUESTIONNAIRE PRIOR TO ADMITTANCE. ANY ATTENDEE SHOWING ANY SIGNS OF ILLNESS OR WHO HAS BEEN EXPOSED TO COVID-19 WITHIN THE LAST 14 DAYS SHOULD NOT ATTEND ANY EVENTS AT FRAWLEY STADIUM.

6. STAFF – ALL STAFF MEMBERS WILL HAVE THEIR TEMPERATURE CHECKED & BE REQUIRED TO COMPLETE A HEALTH QUESTIONNAIRE PRIOR TO WORKING ANY EVENT. PER STATE MANDATES, ALL STAFF WILL BE REQUIRED TO WEAR A FACE COVERING AT ALL TIMES INSIDE FRAWLEY STADIUM AND MAINTAIN AT LEAST 6 FEET OF SOCIAL DISTANCE WHENEVER FEASIBLE. ANY STAFF MEMBER SHOWING ANY SIGNS OF ILLNESS WILL BE SENT HOME UNTIL MEDICALLY TESTED & CLEARED TO RETURN.

7. RESTROOMS - THE THIRD-BASE RESTROOMS AT FRAWLEY STADIUM WILL BE AVAILABLE AT LIMITED CAPACITY AND WILL BE SANITIZED WITH AN EPA LIST 6 APPROVED DISINFECTANT SEVERAL TIMES THROUGHOUT EACH EVENT.

8. SPECTATORS - FRAWLEY STADIUM IS SUBJECT TO STATE-MANDATED CAPACITY LIMITS MUCH BELOW ITS LISTED CAPACITY. CAPACITY WILL VARY BY EVENT. A REMINDER THAT ANYONE ENTERING FRAWLEY STADIUM IS SUBJECT TO HEALTH SCREENINGS, MUST WEAR A MASK AND MUST MAINTAIN PROPER SOCIAL DISTANCING MEASURES.

COVID-19 DISCLAIMER

MOVIE NIGHTS AT FRAWLEY STADIUM

THE NOVEL CORONAVIRUS, COVID-19 (INCLUDING WITHOUT LIMITATION, ANY SUCCESSOR STRAINS OF NOVEL CORONAVIRUS) (HEREINAFTER REFERRED TO AS 'COVID-19'), HAS BEEN DECLARED A WORLDWIDE PANDEMIC BY THE WORLD HEALTH ORGANIZATION ('WHO'). COVID-19 IS EXTREMELY CONTAGIOUS AND IS BELIEVED TO SPREAD MAINLY FROM PERSON-TO-PERSON CONTACT. AS A RESULT, FEDERAL, STATE, AND LOCAL GOVERNMENTS AND FEDERAL AND STATE HEALTH AGENCIES RECOMMEND SOCIAL DISTANCING AND HAVE, IN MANY LOCATIONS, PROHIBITED THE CONGREGATION OF GROUPS OF PEOPLE.

YOU REPRESENT AND WARRANT THAT YOU HAVE FAMILIARIZED YOURSELF WITH THE MOST RECENT GUIDANCE AND PROTOCOLS ISSUED BY THE WHO AND THE CENTERS FOR DISEASE CONTROL PREVENTION ("CDC") FOR SLOWING THE TRANSMISSION OF COVID-19 AND AGREE TO COMPLY THEREWITH. YOU FURTHER REPRESENT AND WARRANT THAT YOU HAVE NOT:

- (I) TRAVELED TO A HIGHLY-IMPACTED AREA SUBJECT TO CDC LEVEL 3 TRAVEL HEALTH NOTICE WITHIN THE LAST FOURTEEN (14) DAYS
- (II) BEEN EXPOSED TO ANY PERSON RETURNING FROM A HIGHLY IMPACTED AREA SUBJECT TO A CDC LEVEL 3 TRAVEL HEALTH NOTICE WITHIN THE LAST 14 DAYS, OR
- (III) BEEN EXPOSED TO ANY PERSON WHO HAS A SUSPECTED OR CONFIRMED CASE OF COVID-19.

FINALLY, YOU AGREE TO ABIDE BY ANY AND ALL RULES AND COVID-19 PROTOCOLS SET FORTH BY WILMINGTON BLUE ROCKS (THE BLUE ROCKS), LIGHT ACTION PRODUCTIONS (LA), AND THE DELAWARE STADIUM CORPORATION (DSC) FOR THIS EVENT.

NOTWITHSTANDING ANY PROTOCOLS PUT IN PLACE FOR THE EVENT, THE BLUE ROCKS, LA AND DSC CANNOT GUARANTEE THAT YOU, AND/OR ANY OF YOUR FAMILY MEMBERS OR OTHER INDIVIDUALS WITH WHICH YOU ARE IN CONTACT WILL NOT BECOME INFECTED WITH COVID-19. FURTHER, ATTENDING THIS EVENT COULD INCREASE YOUR RISK AND/OR YOUR FAMILY MEMBERS' RISK OF CONTRACTING COVID-19.

BY COMPLETING YOUR TICKET PURCHASE, YOU ACKNOWLEDGE THE CONTAGIOUS NATURE OF COVID-19 AND VOLUNTARILY ASSUME THE RISK THAT YOU AND/OR YOUR FAMILY MEMBERS WITH WHICH YOU ARE IN CONTACT WITH MAY BE EXPOSED TO OR INFECTED BY COVID-19 BY ATTENDING THE EVENT AND THAT SUCH EXPOSURE OR INFECTION MAY RESULT IN PERSONAL INJURY, ILLNESS, PERMANENT DISABILITY, AND/OR DEATH. YOU UNDERSTAND THAT THE RISK OF BECOMING EXPOSED TO OR INFECTED BY COVID-19 WHILE ATTENDING THE EVENT MAY RESULT FROM THE ACTIONS, OMISSIONS, OR NEGLIGENCE OF YOURSELF OR OTHERS, INCLUDING, BUT NOT LIMITED TO, THE BLUE ROCKS, LA AND DSC EMPLOYEES AND/OR CONTRACTORS. YOU VOLUNTARILY AGREE TO ASSUME ALL OF THE FOREGOING RISKS AND ACCEPT SOLE RESPONSIBILITY FOR ANY INJURY TO YOURSELF AND/OR ANY OF YOUR FAMILY MEMBERS (INCLUDING, BUT NOT LIMITED TO, PERSONAL INJURY, DISABILITY, AND/OR DEATH), ILLNESS, DAMAGE, LOSS, CLAIM, LIABILITY, OR EXPENSE, OF ANY KIND, THAT YOU AND/OR ANY OF YOUR FAMILY MEMBERS MAY EXPERIENCE OR INCUR IN CONNECTION WITH YOUR ATTENDANCE AT THE EVENT (COLLECTIVELY, "CLAIMS").

ON BEHALF OF YOURSELF, AND ON BEHALF OF YOUR FAMILY MEMBERS, YOU HEREBY RELEASE, COVENANT NOT TO SUE, DISCHARGE, AND HOLD HARMLESS THE BLUE ROCKS, LA AND DSC THEIR EMPLOYEES, AGENTS, PARENTS, SUBSIDIARIES, ASSIGNS, CONTRACTORS AND REPRESENTATIVES, OF AND FROM ANY AND ALL CLAIMS, INCLUDING ALL LIABILITIES, CLAIMS, ACTIONS, DAMAGES, COSTS OR EXPENSES OF ANY KIND ARISING OUT OF OR RELATING THERETO.

YOU UNDERSTAND AND AGREE THAT THIS RELEASE INCLUDES ANY CLAIMS BASED ON THE ACTIONS, OMISSIONS, OR NEGLIGENCE OF THE BLUE ROCKS, LA AND DSC THEIR EMPLOYEES, AGENTS, PARENTS, SUBSIDIARIES, ASSIGNS, CONTRACTORS AND REPRESENTATIVES, WHETHER A COVID-19 INFECTION OCCURS BEFORE, DURING, OR AFTER THE EVENT.
