I certify that my dog is completely up to date on all of its vaccinations, including (but not limited to) rabies, and I have full documentation to prove such claims. All dogs must have valid rabies vaccination tags affixed to their collars.

Further, I hereby grant full permission to any and all of the foregoing to use any photographs, videotapes, motion pictures, or any other record of this event for any promotional purpose.

I understand that the dog must stay on a leash and with me the whole time, and that any aggressive or inappropriate behavior by my dog or me will result in either seating relocation and / or ejection from the ballpark, without refund.

I will pick up after my dog and ensure that all waste be handled appropriately.
