In consideration of being allowed to participate in a dog-friendly program at a Jersey Shore BlueClaws game or special event, the undersigned acknowledges, appreciates and agrees that:

I am an adult over the age of 18, and I have read, fully complied with, and agree to be bound by all terms and conditions of the Event. I certify that I am the owner of and have custody of the dog that I have brought to the ballpark that is identified below. My dog and I are physically able to participate in the Event. I further certify that my dog is current on the following vaccinations:

- Rabies
- DHPP or DLPH (Distemper, Hepatitis, Leptospirosis, Para influenza)
- Parvo (oven included in DHLP)

I further agree to indemnify the Releasees with respect to any and all in jury, disability, death or loss or damage to person or property that is caused by my dog or myself while attending the Event at FirstEnergy Park.

I hereby agree that the Releasees shall have the right to use the name, voice, likeness, photograph, videotaped footage and biographical information of my dog and/or myself, in whole or in part, for advertising, promotional and trade purposes in any and all media now known or hereafter developed, in perpetuity, without notice or further obligation to me and without further compensation, except where prohibited by law.
