# 2020 BASEBALL CAMP

## WAIVER OF LIABILITY RELEASE OF ALL CLAIMS AND INDEMNITY

In consideration of the baseball instruction and lessons being provided to my minor child at the Baseball Camp run by the Binghamton Rumble Ponies, the undersigned, being all of the parents and/or legal guardians of said minor child hereby acknowledge their understanding and awareness of the risks inherent to the game of baseball and the operation of an instructional baseball camp, and release and forever discharge Evans Street Baseball DBA the Binghamton Rumble Ponies, the Eastern League, and the City of Binghamton, and any sponsors or contributors along with their agents, employees, directors, officers, and successors and assigns, from any and all claims, demands, actions, judgments, and executions which the undersigned ever had, or now have, or may have whether the claim is a personal claim or one which is being pursued derivatively for the benefit of the child, for all personal injuries, known or unknown, and injuries to property caused by, arising out of, or in any way connected with the above services being provided to the minor child, including any activities which may occur on or about the premises before or after the service is to be provided. It is intended that this Waiver and Release be constructed as broadly as possible and it is intended to include any and all negligence (simple, gross, or otherwise) on the part of Evans Street Baseball DBA the Binghamton Rumble Ponies Club, Inc., the Eastern League and the City of Binghamton and any sponsors or contributors along with their agents, employees, directors, officers, and successors and assigns.

In addition to the above Waiver and Release, the undersigned personally agree to indemnify and hold harmless Evans Street Baseball DBA the Binghamton Rumble Ponies, the Eastern League, and the City of Binghamton, and any sponsor or contributors, along with their agents, employees, directors, officers, and successors and assignees of and from any and all loss, damage, expense (including reasonable attorney fees), claims, judgments, executions, demands and any other actions caused by or arising out of or in any way connected with the minor child's participation in this activity.

COVID-19 CLAUSE: PARTICIPATION IN BINGHAMTON RUMBLE PONIES ACTIVITIES INCLUDES EXPOSURE TO AND ILLNESS FROM INFECTIOUS DISEASES INCLUDING BUT NOT LIMITED TO MRSA, INFLUENZA, AND COVID-19. WHILE PARTICULAR RULES AND PERSONAL DISCIPLINE MAY REDUCE THIS RISK, THE RISK OF SERIOUS ILLNESS AND/OR DEATH DOES EXIST; AND, I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS FOR MYSELF AND MY CHILDREN, BOTH KNOWN AND UNKNOWN, FROM ANY ILLNESSES OR INJURIES, EVEN IF ARISING FROM THE NEGLIGENCE AND RELEASES OF OTHERS, AND ASSUME FULL RESPONSIBILITY FOR MY PARTICIPATION; AND, I WILLINGLY AGREE TO COMPLY WITH THE STATED AND CUSTOMARY TERMS AND CONDITIONS FOR PARTICIPATION AS REGARDS PROTECTION AGAINST INFECTIOUS DISEASES; AND, I, FOR MYSELF AND ON BEHALF OF MY HEIRS, ASSIGNS, PERSONAL REPRESENTATIVES, AND NEXT OF KIN, HEREBY RELEASE AND HOLD HARMLESS EVANS STREET BASEBALL AND THE BINGHAMTON RUMBLE PONIES OFFICERS, OFFICIALS, AGENTS, EMPLOYEES, OTHER PARTICIPANTS, SPONSORING AGENCIES, SPONSORS, ADVERTISERS, VOLUNTEERS, AND IF APPLICABLE, OWNERS AND LESSORS OF PREMISES USED TO CONDUCT THE EVENT ("RELEASES"), WITH RESPECT TO ANY AND ALL ILLNESS, INJURY, DISABILITY, DEATH, OR LOSS OR DAMAGE TO PERSON OR PROPERTY, WHETHER ARISING FROM THE NEGLIGENCE OF RELEASES OR OTHERWISE, TO THE FULLEST EXTENT PERMITTED BY LAW.
