

## MIDLAND ROCKHOUNDS 2025 DOG WAIVER

Complete and present at Momentum Ballpark Front gate for admission to the 2025 Bark in the Park Days on <u>April 16,2025</u>, <u>April 30,2025</u>, & <u>May 14, 2025</u>.

Please note, completion of the waiver does not secure a game ticket. Visit midlandrockhounds.org for more information on Bark in the Park nights.

Mandatory conditions to ensure a safe environment for dogs, owners, players, fans, staff, etc. include, but are not limited to:

- KEEP DOGS IN PICNIC AREAS OR OUTFIELD GRASS BERM AREAS.
- The owner is responsible for bagging and disposing of any waste created by their dog.
- Dogs must be always on a leash no longer than six feet long.
- Owners are responsible for the actions of their dog, including any sort of injury or damage caused by the dog.
- Children with dogs must be accompanied by an adult.
- Any dogs acting inappropriately will be asked to leave by RockHounds staff.
- One dog per person per day.
- Do not bring a dog that is in season.

Kennel Cough or Tracheobronchitis

- Bring your dog only is he/she enjoys being around other people and other dogs.
- Dog owners must sign a release of liability stating that the dog's vaccinations from a licensed vet are current. The waiver/release would hold the dog owner responsible for all liability in the event of an incident. The following is a list of vaccinations that are required:
   Rabies given annually, but sometimes can be a 3 year.
   DHLP (Distemper, Hepatitis, Leptospirosis, Para influenza) all given annually, sometimes referred to as the Combo Vaccination, especially when it includes Parvo.
   Bordetella given either every six months or annually. Sometimes referred to as:

Failure of any of the above may result in a dog needing to leave the premises.

I AGREE AND ADHERE TO ALL EVENT CONDITIONS LISTED ABOVE. I STATE THAT MY DOG IS NON-AGGRESSIVE, GOOD IN CROWDS OF DOGS AND PEOPLE, NOT IN HEAT AND IN GOOD HEALTH. I HEREBY RELEASE ANY CLAIM NOW OR HEREAFTER EXISTING AGAINST THE MIDLAND ROCKHOUNDS, THE CITY OF MIDLAND AND ALL SPONSORS OF THE EVENT AT MOMENTUM BANK BALLPARK WHICH I MAY HAVE RESULTING IN MY DOG'S PARTICIPATIONF THEREIN. I FUTURE AGREE TO DEFEND, INDEMNIFY, AND HOLD HARMLESS FROM ALL CLAIMS BY ANY PARTIES RESULTING FROM THE ACTIONS OF MY DOG IN CONNECTION THEREWITH, WHETHER CAUSED BY THE NEGLIGENCE OF THE RELEASEES, OR OTHERWISE, WHILE PARTICIPATING IN SUCH ACTIVITY, OR WHILE IN, OR UPON THE PREMISES WHERE THE ACTIVITY IS BEING CONDUCTED. I ASSUME ALL RISK OF PROPERTY DAMAGE, AS WELL AS PERSONAL INJURY TO MYSELF AND MY DOG THAT ARISE FROM OUR PARTICIPATION IN THIS EVENT, OR THAT MAY BE INCURRED DURING THE BALLGAME. THE HOLDER ASSUMES ALL RISK AND DANGER INCIDENTAL TO THE GAME OF BASEBALL WHETHER PRIOR TO, DURING OR SEBSEQUENT TO THE ACTUAL PLAYING OF THE GAME INCLUDING SPECIFICALLY, "BUT NOT EXCLUSIVELY" THE DANGER OF BEING INJURED BY THROWN BATS OR BATTED BALLS AND AGREES THAT THE PARTICIPATING CLUBS, AGENTS, PLAYERS, AND SPONSORING ORGANIZATIONS ARE NOT LIABLE FOR INJURIES RESULTING FROM SUCH CAUSES. THE MANAGEMENT RESERVES THE RIGHT TO REVOKE THE LICENSE GRANTED BY THIS TICKET BY REFUNDING THE PURCHASE PRICE.
