

AVIATORS BASEBALL BINGO

Official Rules

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. ODDS OF WINNING DEPEND ON THE TYPE AND ORDER OF GAME EVENTS THAT OCCUR AND WHETHER A RANDOMLY GENERATED BINGO GAME BOARD RESULTS IN A WINNING EVENT. VOID WHERE PROHIBITED BY LAW.

ALL DISPUTES WILL BE RESOLVED SOLELY BY BINDING ARBITRATION, AND ENTRANTS WAIVE THE ABILITY TO BRING CLAIMS IN A CLASS ACTION FORMAT. TRAVEL NOT INCLUDED WITH ANY PRIZE.

SPONSOR

Aviators Baseball Bingo (“Bingo”) is sponsored solely by **Las Vegas Aviators** (“Las Vegas Aviators” or “Sponsor”), located at Las Vegas Ballpark, 1650 S Pavilion Center Dr, Las Vegas, NV 89135.

ELIGIBILITY

Bingo is open to legal residents of the fifty (50) United States and Washington, D.C., who, at the time of participation, are of legal age of majority in their jurisdiction (and at least eighteen (18) years of age or older).

Employees and officers of Sponsor and each of their respective parent companies, subsidiaries, affiliates, advertising agencies, authorized dealers, promotional suppliers, and prize providers (collectively, “Bingo Entities”), as well as the immediate family members (spouses, parents, children, and siblings and their spouses) or members of the same household (whether related or not) of such individuals, are not eligible to enter or win. **Void where prohibited.**

ENTRY PERIOD

The Bingo game will begin at the official start of the **Regular Season Game** played on **March 27, 2025**, and will end at the official end of the final regular season game on **September 13, 2026**.

The Bingo game will be divided into separate events for each **Las Vegas Aviators home game** (each, an “**Entry Period**”), beginning at the start of that game and ending at its conclusion. **Limit one (1) Bingo board per person per Regular Season Game.**

HOW TO PARTICIPATE

To participate, you must download the **Las Vegas Ballpark app** from the Apple App Store or Google Play (the “**Application**”) to your mobile device.

1. Open the Application.
2. Navigate to the **Las Vegas Aviators** page.
3. Click the “**Aviators Baseball Bingo**” button.
4. A randomly generated Bingo board for the current Entry Period will appear.
5. Game Events will automatically be checked off as they occur (use the refresh button if needed).

Only mobile participation is allowed. **Standard message and data rates may apply.** Use of the Application is subject to its Terms of Use.

WINNER DETERMINATION

There are **three (3)** ways to win:

- **Single Bingo:** Game Events in a row (horizontally, vertically, or diagonally).
- **Diamond Bingo:** Game Events forming a diamond.
- **Blackout Bingo:** All Game Events on the board are marked.

Upon a winning event, a **pulsing button** will appear in the Application.

You must click the pulsing button to submit your board. YOU MUST CLICK TO WIN.

For each Entry Period:

- The **first 12 participants** who click after completing a Single Bingo will be **Entry Period Single Winners**.
 - All fans must be in attendance to win the Single Bingo prize and must have a ticket to the game to claim the prize
- The first **seven (7) participants** to click for a **Diamond Bingo** will be **Diamond Winners**.
- The first **two (2) participants** to click for a **Blackout Bingo** will be the **Blackout Winners**.

PRIZES

- **Bingo Game Single Prizes:** 200 Points to the first 12 winners. 25 points to all other winners.
ARV: \$0
- **Diagonal Prizes:** \$20 in **Loaded Wallet Credit** + 300 Points. 100 points to all other winners
ARV: \$20
- **Blackout Prize:** \$50 in **Loaded Wallet Credit** + 600 points. 200 points to all other winners
ARV: \$50
- **Monthly Winners:** Aviators Prize Package. **ARV:** \$150
- **Season Long Winers:** Aviators VIP Prize Package. **ARV:** \$400

Prizes are non-transferable and have no cash value unless otherwise stated.

ODDS

Odds of winning depend on the number and sequence of Game Events, Bingo board configuration, and timing of entries. Not all Entry Periods may result in prize awards.

WINNER NOTIFICATION

Winners will be notified via the Application. Follow all the instructions within the notification to claim your prize.

CONDITIONS OF PARTICIPATION

Participation in Bingo constitutes acceptance of these Official Rules and consent to use participant's name, likeness, and city of residence for promotional purposes without additional compensation, where permitted by law.

By entering, participants release the Sponsor and Bingo Entities from any claims, damages, or liabilities arising from participation or prize use.

ARBITRATION & GOVERNING LAW

All disputes shall be resolved individually and exclusively through final and binding arbitration held in **Clark County, Nevada**, administered by the American Arbitration Association.

No class actions are permitted. These Official Rules are governed by **Nevada law**.

DISQUALIFICATION

Sponsor reserves the right to disqualify any individual found to be tampering with the operation of the game or in violation of these rules.
