IMPORTANT HEALTH & WELLNESS SCREENING, WAIVER & RELEASE OF LIABILITY

By accepting admission to the premises, the undersigned admittee, participant, visitor, spectator, guest, vendor, or ticket holder (All collectively referred to as "Attendee"), on behalf of himself/herself and on behalf of any minor accompanying Attendee to the event ("Minor(s)"), agrees to the following terms and conditions. This agreement shall be governed by the laws of the state of Arkansas. Attendee is solely responsible for reading and understanding this agreement.

In consideration of permission to enter Dickey-Stephens Ballpark and adjacent associated areas ("the Premises"), Attendee acknowledges and agrees to the following:

Acknowledgement of Potential Exposure

Naturally occurring disease processes, including but not limited to the novel coronavirus or COVID-19, (collectively, the "Naturally Occurring Diseases") may exist in the community, including among guests and staff employed at the Premises. The Naturally Occurring Diseases create an inherent risk of transmission to attendees and staff employed at the Premises. Despite what the Released Parties (as defined below) believe are the reasonable efforts, feasible under the circumstances, to mitigate risk by cleaning the Premises, warning and screening our patrons and employees, and requesting the maintenance of "social distancing," there remains an inherent risk of exposure to the Naturally Occurring Diseases.

Health & Wellness Screening

Prior to coming to the Premises, Attendee represents and warrants that Attendee and Minor(s) have conducted a health assessment and certify all of the following:

- Neither Attendee nor Minor(s) are experiencing any of the following symptoms:
 - o A Fever of 100.4°F or greater
 - o A new or worsening cough
 - Shortness of breath or difficulty breathing
 - o Diarrhea
 - Muscle pain
 - Sore throat
 - Headache
 - Loss of taste or smell
 - o Chills or repeated shaking with chills
- Attendee and Minor(s) have been Fever free (without the use of fever-reducing medications) for at least 72 hours before entering the Premises

- Neither Attendee nor Minor(s) have been in close contact with anyone who has exhibited any COVID-19 symptoms
- Neither Attendee nor Minor(s) have been in contact with anyone who has tested positive for COVID-19
- Neither Attendee nor Minor(s) have been directed to self-isolate or quarantine by their health care provider or public health official

Assumption of Risk, Waiver & Release of Liability

Attendee recognizes that attendance of Attendee and Minor(s) at the Premises is voluntary and may result in exposure to and transmission of Naturally Occurring Diseases. Attendee further acknowledges and accepts that it is Attendee's sole responsibility to determine whether to subject Attendee and Minor(s) and, individuals with whom Attendee and Minor(s) may later come in contact, to the inherent risk of infection that attendance at the Premises entails. By using this ticket and by entering the Premises, **Attendee, on behalf of himself/herself and Minor(s), acknowledges and assumes all risks and dangers associated with Attendee and/or Minor(s) entering the Premises and being exposed to Naturally Occurring Diseases, including but not limited to contraction of COVID-19.** Attendee agrees that the Premises, The <u>Arkansas Travelers,</u> their owners, lessees and all of their officers, agents, and employees (collectively, the "Released Parties") will not be responsible for any personal injury (including death) or other loss suffered from exposure to or contraction of Naturally Occurring diseases as a result of Attendee's and/or Minor(s)' attendance at the Premises or any negligence of the Released Parties.

BY ATTENDING THE PREMISES, ATTENDEE, ON HIS/HER OWN BEHALF AND ON BEHALF OF MINOR(S), KNOWINGLY AND VOLUNTARILY ASSUME THE RISK OF EXPOSURE TO NATURALLY OCCURING DISEASES AND POSSIBLE INFECTION AND IS DEEMED TO HAVE GIVEN A FULL RELEASE OF LIABILITY TO THE RELEASED PARTIES TO THE FULLEST EXTENT PERMITTED BY LAW.
