## **Budweiser Sweepstakes ("Sweepstakes")**

## **OFFICIAL RULES ("Rules")**

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. ODDS OF WINNING WILL DEPEND ON THE TOTAL NUMBER OF ENTRIES RECEIVED DURING THE SWEEPSTAKES PERIOD. VOID WHERE PROHIBITED BY LAW. ALL DISPUTES WILL BE RESOLVED SOLELY BY BINDING ARBITRATION AND ENTRANTS WAIVE THE ABILITY TO BRING CLAIMS IN A CLASS ACTION FORMAT.

ELIGIBILITY: The Sweepstakes is open only to persons who, at the time of entry, are twenty-one (21) years of age or older at the time of entry and are legal residents of the State of Oklahoma. Employees, officers, and directors (including immediate family members – ie spouse, parent, child, sibling and their respective spouses, regardless of where they reside – and members of the same household, whether or not related) of the Oklahoma City Dodgers (the "Dodgers") and Anheuser-Busch ("Sponsor"), and each of their respective parents, affiliated companies, subsidiaries, licensees, distributors, dealers, retailers, printers, advertising and promotion agencies, and any and all other companies associated with the Sweepstakes are not eligible to participate or win a Grand Prize ("Grand Prize") (each Grand Prize) may individually referred to as a "Prize" and collectively, as "Prizes"). Participation in the Sweepstakes constitutes participant's full and unconditional agreement to, and acceptance of, these Rules and the results of the random drawing described below. This Sweepstakes is offered only in the State of Oklahoma and is subject to applicable federal and state laws.

<u>SWEEPSTAKES PERIOD</u>: The Sweepstakes period will begin at 12:00 AM Central Time ("CT") on April 1, 2022, and end at 11:59 PM CT on September 3, 2022 ("Sweepstakes Period").

<u>HOW TO ENTER</u>: To enter the Sweepstakes, simply send a text message with the keyword provided by a participating store to the corresponding shortcode number via mobile device. Entrants must fully complete and submit all non-optional data requested upon texting the shortcode number to be eligible. Incomplete and/or inaccurate entries are void. All data inputted via text message to the shortcode becomes the property of Sponsor. No other method of entry will be accepted. Limit one (1) entry per person/mobile phone number. Additional entries beyond the specified limit will be void. Non-winning eligible entries from the Sweepstakes will not carry over to any subsequent sweepstakes or promotion.

RANDOM DRAWING: The first of five prize winners of the Sweepstakes will be selected by random drawing on or about April 26, 2022 from among all eligible entries received during the Sweepstakes Period (each a "Winner" and collectively, the "Winners"). Subsequent prize winners will be selected on May 24, June 21, August 9 and September 6, 2022. The decisions of Sponsor are final and binding on all matters relating to the Sweepstakes. Odds of winning depend on the total number of eligible entries received during the Sweepstakes Period.

<u>GRAND PRIZE</u>: There will be five (5) Grand Prizes awarded i.e. one (1) Grand Prize to each winner. Each Grand Prize will include four (4) game tickets and one (1) parking pass to attend a preselected Oklahoma City Dodgers game. Each Grand Prize will include \$40 in Dodgers Dollars and a bag of souvenirs.

<u>PRIZE NOTIFICATION RESPONSE TIME</u>: Forty-Eight (48) hours from the time of issuance of the Prize Notifications (defined below) (the "Required Response Time").

<u>PRIZE CONDITIONS</u>: All Grand Prize details, including, without limitation, the exact game date and seat locations at the game, if any, shall be determined in the sole and absolute discretion of Sponsor and/or Dodgers, as applicable. Each Winner is fully responsible for any and all applicable federal, state, territory, provincial and local taxes (including income and withholding taxes). Sponsor and the Dodgers reserve the right, in their absolute discretion, to cancel or suspend the Sweepstakes (or any portion thereof) should virus, bugs, unauthorized human intervention, or other causes corrupt administration, security, fairness, integrity or proper operation of the Sweepstakes (or any portion thereof). In the event of cancellation, Sponsor may elect to identify Winners and award the Prizes by way of random drawing from among all non-suspect, eligible entries received up to the time of such cancellation. Sponsor and the Dodgers also reserve the right, in their absolute discretion, to modify these Rules for clarification purposes without materially affecting the terms and conditions of the Sweepstakes.

Entries generated by a script, macro, or other mechanical or automated means will be disqualified. Each participant further agrees that: (i) all disputes will be determined by a competent court of jurisdiction in Oklahoma County, Oklahoma, and (ii) he or she submits to the in person jurisdiction of such court.
