Thank you for your interest in the Beloit Sky Carp's "Bark at the Park" event (the "Event")! Please carefully review the following information and, if you still wish to participate in the Event after reading this information, please sign this form to indicate your agreement.

Release & Waiver of Liability

I hereby acknowledge that my voluntary participation in the Event, located at ABC Supply Stadium in Beloit, Wisconsin (the "Ballpark") may result in personal injury to me and/or my dog(s) ("Dog"). By participating in, attending and/or observing the Event, I acknowledge and assume all risks and danger to me that are incidental to or in any way arise from the Event, including, without limitation, all risks and danger inherent in a canine-oriented event (e.g., dog bites, fights or altercations, falls, contact with spectators at the Event) or the sport of baseball (e.g., throwing and/or batted balls, thrown bats, or contact or collisions with any other persons).

I accept personal responsibility for any and all actions of the Dog, including without limitation any damage to persons, property, and/or other dogs, and agree that the Dog will be in my care and control during the Event. I acknowledge that the Dog may be only on the Concourse or in the seating bowl; if I attempt to enter the Beloit Health System Club, First National Bank & Trust Suite with my Dog I understand I will need to be escorted to Concourse by an authorized representative of the Beloit Sky Carp. I understand that I am responsible for cleaning up after my Dog at all times during the Event.

I hereby represent and confirm that the Dog is in good health and current on all vaccinations, including Rabies, Distemper, Parvo, Leptospirosis, Parasites, Bordetella and that the Dog is not the subject of a quarantine order, a pending adjudication or administrative hearing, and has never been declared a dangerous, potentially dangerous, or vicious or potentially vicious dog. I agree to be bound by the terms of the rules and regulations established by the Beloit Sky Carp and the City of Beloit, as applicable, for both the Ballpark and the Event, and I will abide by all applicable governmental laws, ordinances, orders, directions, rules and regulations as well as all rules and regulations that are adopted for this Event by the Beloit Sky Carp, the City of Beloit, or its respective representatives. I acknowledge the Beloit Sky Carp reserve the right to exclude or eject any and all unruly, rowdy or disruptive Owner or Dog from the Event and/or the Ballpark without liability and that I shall be fully responsible for any damages or expenses, direct or indirect, incurred as a result of my or my Dog's disruptive behavior and/or ejection. I further agree that any Ballpark official may authorize necessary treatment for me and/or the Dog in the event of injury.

I understand that Gateway Professional Baseball, LLC, the Riverbend Stadium Authority, its affiliates, and their respective owners, employees, and representatives (collectively, the "Beloit Sky Carp"), are not responsible for me, including any injury or damage to me, my Dog, or my property while I am participating in the Event. **I AGREE THAT I WILL NOT SUE THE BELOIT SKY CARP FOR ANY CLAIMS, INJURIES, OR DAMAGES THAT MAY OCCUR AS A RESULT OF MY PARTICIPATION. I UNDERSTAND THAT I AM SOLELY LIABLE FOR ANY INJURY TO PERSONS AND/OR OTHER DOGS AND DAMAGE TO PROPERTY CAUSED BY THE DOG. I HEREBY AGREE TO PROTECT, INDEMNIFY, DEFEND AND HOLD HARMLESS THE BELOIT SKY CARP AND ANY OF ITS AFFILIATED ENTITIES, MAJOR LEAGUE BASEBALL AND EACH OF ITS MEMBER CLUBS, ANY SPONSOR OF THE EVENT, THE CITY OF BELOIT AND OTHER AFFILIATED ENTITIES OF THE BELOIT SKY CARP (COLLECTIVELY, THE "INDEMNITEES"), FROM AND AGAINST ANY AND ALL ACTIONS, CAUSES OF ACTION, CLAIMS, SUITES, DEMANDS (OR OTHER LEGAL ACTIONS), LOSSES, DAMAGES, COSTS AND/OR EXPENSES (INCLUDING, WITHOUT LIMITATION, REASONABLE ATTORNEY'S FEES AND DISBURSEMENTS) FOR PERSONAL INJURY, PROPERTY**

If any portion of this agreement is held invalid or unenforceable by a court of competent jurisdiction, the remaining provisions shall be deemed severable and enforced to the maximum extent consistent with the law.
