

NASHVILLE SOUNDS “12 DAYS OF GIVEAWAYS” PROMOTION

OFFICIAL RULES

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCES OF WINNING. Void outside the fifty (50) United States and the District of Columbia, and where prohibited by law. The Promotion is in not associated with Facebook, Twitter, Instagram, Snapchat, and/or Emma.

Promotion and Entry Periods: The Nashville Sounds “12 Days of Giveaways” Promotion (the “Promotion”) begins on December 3, 2020 at 8:00 a.m. Central Time (“CT”) and ends on December 15, 2020 at 11:59 p.m. CT (the “Promotional Period”). The Promotion will consist of twelve (12) individually unique promotions that will be conducted daily during the Promotional Period beginning in the afternoon and concluding the following morning with the announcement of a winner each day on Twitter, Facebook or Instagram, except for Friday and weekend promotions, which will conclude with the announcement of a winner on Monday mornings on the platform the contest was held on (each, an “Entry Period” and collectively, the “Entry Periods”). Entries received outside of an Entry Period will not be accepted or be eligible to win a prize. The winner announcement on Twitter is the official time-keeping device for the Promotion.

Eligibility: The Promotion is open to legal residents of the United States who are at least eighteen (18) years old or the age of majority in their jurisdiction of residence at the time of entry. Entrant explicitly acknowledges and agrees that Sponsor reserves the right to publish in any media, including on its social media accounts, your entry with/without first and last name or username credit to the entrant. Sponsor reserves the right in its sole discretion to disqualify any entry.

1. Winner Selection, Notification, and Prize Delivery/Pick-Up: Following each Entry Period, Sponsor will select one winner daily on the specified Platform of the day in a random drawing from among all eligible entries received during the Promotion/Entry Period. Odds of winning a prize will vary depending on the total number of eligible entries received during each Entry Period. The random drawing will be conducted by Sponsor, whose decisions are final on all matters. For Promotional Posts that solicit for an answer that may be correct/incorrect, whether the answer is "correct" will be confirmed by the Sponsor's sole discretion.

Winners will be notified by direct message via the Platform he/she entered the Promotion through. All winners may be subject to verification of eligibility, and may be required to sign and return a Prize Acceptance Form upon prize pick up. Winners must respond within thirty (30) days of notification in order to receive prize. If a potential winner cannot be reached (regardless of reason), does not respond within thirty (30) days, he/she will be disqualified. Upon disqualification, no further compensation will be given or negotiated. Failure to comply with any term or condition in these Official Rules may result in the disqualification at

Sponsor's sole discretion. In the event that the potential winner is disqualified for any reason, the applicable prize will remain unawarded.
