

12-MONTH AUTO-RENEWAL PAYMENT PROGRAM FOR FUTURE SEASONS ☐

Starting with the 2026 season, for the Member to be eligible for this 12-Month Auto-Renewal Payment option, the Member agrees to an automatic renewal payment schedule of the same Membership(s) in this Agreement for each season included in this Agreement.

12-Month Auto-Renewal Payments will begin in August for the upcoming season and occur in regular monthly intervals through July of the respective season.

A written Renewal Notice will be provided to the Member at least 7 days prior to the first scheduled Auto-Renewal payment beginning in August for the upcoming season. This renewal notice will specify any changes to the price of the Season Seat Membership(s) for the upcoming season and include payment dates for all future automatic payments. If applicable, pricing changes for each season included in this Agreement will adhere to all pricing parameters set forth in this Agreement.

After enrollment in the 12-Month Auto-Renewal Payment Program, Member will receive a Ballpark Credit Rebate equal to 2% of the annual total Membership ticket cost for each season to use in the Chihuahuas Team Shop or for food and beverage at Southwest University Park during Chihuahuas regular season games within the same season.

EPSOC reserves the right to withhold the 2% Ballpark Credit Rebate if Member becomes past due on any Auto-Renewal payments throughout the term length. EPSOC reserves the right to introduce new pricing or changes to membership benefits before each season, in phases, or at once before the start of the applicable season, in accordance with all pricing parameters set forth in this agreement. All payments made by the Member become non-refundable upon receipt of payment.

The 2% Ballpark Credit Rebate applies to the 12-Month Auto-Renewal Payment Program only and does not apply to any other payment plan option including initiating enrollment in the 12-Month Auto-Renewal Payment Program and utilizing a different payment plan in subsequent seasons included in this Agreement.

Opt-Out of the Auto-Renewal Program for Future Season(s) ☐

Member may opt-out of auto-renewal to purchase Membership(s) for the next season at any time before the first scheduled Auto-Renewal payment of the year immediately preceding the start of the applicable season by providing an opt-out notice to EPSOC via email to Sr. Director, Ticket Sales & Service Nick Seckerson at nseckerson@epchihuahuas.com or by certified mail to 1 Ballpark Plaza, El Paso, TX 79901 Attention: Nick Seckerson.

An initial deposit of 15% of the total cost due for each future year beginning with the 2026 Season will be due by September 1st. In order to retain a seat location from the previous season, this initial deposit must be received and successfully processed by EPSOC by September 1st of each year preceding the applicable season. All payments made by the Member become non-refundable upon receipt of payment by EPSOC.

Should Member provide opt-out notice following the applicable procedure above, Member will be released from future automatic payments and terminate any obligation to maintain membership for the upcoming season. As such, Member will also relinquish right to the seats assigned in this Agreement and membership benefits for the upcoming season. An opt-out of future membership does not affect membership for the remainder of the current season.

If an opt-out notice is not received by EPSOC on or before the first scheduled auto-renewal payment, or any auto-renewal payments for the upcoming season have been processed, Member will retain obligation to continue the renewal of membership based on the price and payment terms provided in the written Renewal Notice.
