

Going, Going, Gone Promotion

Eligibility

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO PARTICIPATE. This promotion ("Promotion") is open only to individuals ("Entrants") who are legal residents of the State of Oklahoma that are 18 years or older. Lewis RV Center (the "Sponsor"), the Oklahoma City Dodgers ("Dodgers"), advertising, promotion and fulfillment agencies and each of their respective parents, subsidiaries, affiliates, employees, officers, directors, and members of the immediate family or household of each of the above are not eligible to participate. This Promotion is offered only in Oklahoma and is subject to applicable federal and state laws. NO PURCHASE NECESSARY. VOID WHERE PROHIBITED BY LAW.

Participation

To qualify, Participant must sign-up at the Promotions Kiosk at a Dodgers home game or via the Dodgers website. Participants are subject to the above Eligibility rules and must be residents of the State of Oklahoma.

Promotional Period

The Promotion will begin and the submission window will be open on June 9, 2021 and end on August 20, 2021.

Prize

The prize is as follows ("Prize"):

- Use of an RV for 4 days and 3 nights at one of three locations selected by Lewis RV Center
- Date of use will be mutually agreed on by Sponsor and Prize winner

Transportation

Sponsor will transport RV to and from agreed upon location. It is the sole responsibility of the Prize winner to find transportation to and from the agreed upon location. All travel and accommodations will be booked in the sole discretion of the Dodgers and the Sponsor.

Within one week after the end of the Promotion, three randomly selected participants will be chosen for the opportunity to be the Prize winner. If the potential participants cannot be reached or does not respond within seventy-two (72) hours of the first notification attempt, is found to be ineligible, or declines to accept the opportunity to win the Prize, the potential winner may be disqualified at Sponsor's sole discretion, and in such case, Sponsor will select an alternate participant from remaining eligible entries.
