

OFFICIAL RULES AND REGULATIONS

Pricing: 1 for \$1, arm length for \$5, body length for \$20

- Tickets for sale when gates open up until the 7th inning
- Raffle tickets can be obtained at 50/50 RAFFLE kiosks or from a 50/50 RAFFLE seller (wearing a bright orange sign) roaming throughout the stadium
- Jackpot updates will be displayed between innings
- Cumulative jackpot from April 8th-September 11th:
 - Winner will be announced before the 8th inning on September 11th
- Must be 18 years or older to enter

By purchasing a Raffle ticket, the entrant agrees to abide by all terms of the Official Rules applicable thereto. Subject to all Federal, State, Local and Municipal Laws and regulations. By entering any 50/50 RAFFLE, Entrants agree to abide by all terms of these Official Rules. All 50/50 RAFFLES shall be subject to all Federal, State, Local and Municipal Laws and Regulations. Some restrictions apply. Void where prohibited or restricted by law.

1. The Winston-Salem Sports Foundation 50/50 Raffle will be conducted at Dash home games starting on April 8th, 2022 vs. the Hickory Crawdads and continuing through the end of the 6th inning on September 11th, 2022 vs. the Brooklyn Cyclones. The grand prize for the Raffle will be fifty percent (50%) of the net proceeds from the cumulative sale of Raffle tickets during the Raffle Period (the "Grand Prize"). The Grand Prize will be, in accordance with North Carolina law (N.C. Gen. Stat. § 14-309.15; § 105-130.11 et seq (d)), a maximum of One Hundred Twenty Five Thousand dollars (\$125,000).
2. ELIGIBILITY. Participants must be legal U.S. residents eighteen (18) years of age or older and do not need to be present to win any prize. Volunteers, employees, directors, officers and agents of the Winston-Salem Dash, BB&T Ballpark and the Winston-Salem Sports Foundation and each of their respective affiliates, subsidiaries, distributors, suppliers and advertising, promotional or judging agencies as well as immediate family members of such employees are not eligible to win. Void wherever prohibited or restricted by law.
3. PURCHASE LOCATIONS. Raffle tickets can be purchased from any of the roaming Raffle distributors between the time that the doors open and the end of the 6th inning.
4. WINNER SELECTION AND SECOND PRIZES. The one (1) Grand Prize-winning ticket will be randomly selected between the 6th and 7th inning game on September 19th, 2021 vs. the Asheville Tourists. The winning ticket number will be announced over the Truist Stadium PA system and displayed on the scoreboard and various video monitors throughout the stadium. The winner need not be present at the September 19th game to win or claim the Grand Prize.
5. ODDS OF WINNING. The odds of winning depend on the number of Raffle tickets purchased by an individual and the total number of Raffle tickets purchased.
6. WINNER NOTIFICATION/RELEASES. The winning ticket numbers will also be displayed at www.milb.com/winston-salem/5050 within one (1) business day after the selection of the Grand Prize winning number. If the winner is not present during the in-game drawing, they should call the Dash administrative office at (336) 714-2287. Official Winston-Salem Dash 50/50 Raffle tickets are the only valid receipts and the only acceptable proof allowed for claiming a prize. All prizes must be claimed in person or via nationally recognized courier service by signing and returning a winner affidavit of eligibility, liability/publicity release, and, if applicable, a Waiver and Release of Liability form or the prize will be forfeited and donated to the Winston Salem Sports Foundation. Except where prohibited by law, acceptance of a prize constitutes winner's permission for the Sponsor and any of the Promotion Entities to use winner's name, photograph, likeness, voice, biographical information, statements and address (city and state) for advertising and/or publicity purposes worldwide and in all forms of media now known or hereafter developed, in perpetuity, without further compensation.
