Mandatory conditions to ensure a safe environment for dogs, owners, players, fans, staff, etc. include, but are not limited to:

- Dog(s) must stay in designated area located on the general admission outfield lawn
- Dog(s) are not allowed in the stadium seating areas
- Dog(s) must always be on a leash (six-foot maximum length)
- Children with dog(s) must always be accompanied by an adult 18 years of age or older
- Owners who lack or do not provide adequate control over their dog(s) or dog shows aggressive behavior toward other animals or individuals will be asked to leave the premises without a refund
- Owners must promptly bag and dispose of any waste created by their dog(s)
- All dog(s) must have current rabies vaccinations and completion of this form verifies that your dog(s) have up-to-date tags/certificates

Failure of any of the above may result in dog needing to leave the premises.
