A Come-from-Behind Win at The Derek Jeter Center at Phoenix House

his is the story of a young man who started life with a number of strikes against him. But with the help of the Derek Jeter Center at Phoenix House, he was able to overcome the odds and defeat his worst opponent, addiction.

Jordon's father was rarely around while he was growing up. His mother was distant and difficult to talk to, and his family had a history of addiction and criminal behavior. Although Jordon had once earned above-average grades in school, he began experimenting with marijuana when he was 14 and soon began neglecting assignments, skipping school, and eventually failing most of his courses. Matters weren't helped by his classmates; they made him feel uncomfortable about his family's past run-ins with the law. Jordon's feelings of loneliness led him to hang out with a group of kids who regularly used marijuana—their shared drug habit made Jordon feel like part of the crowd.

The turning point came when Jordon was arrested at school for possession of marijuana, although he claimed he was just holding the drug for a friend. Fortunately, Jordon was deemed eligible for treatment rather than juvenile detention, and began outpatient counseling at the Derek Jeter Center at Phoenix House. He and his counselor established a strong rapport,

and Jordon began learning about the negative effects of drugs as well as the legal consequences of using. Most important, he began to understand and address the roots of his own drug use and destructive behaviors.

Today Jordon is 15 years old and has been clean for six months. He is back on track in school and is even taking advanced placement classes. He looks forward to the future with optimism and ambition.



a research scientist or a biochemist. To offset her studies, she takes part in peer tutoring and mentoring and is a volunteer at a meditation clinic. One of Amy's personal goals is to become a stronger, more adventurous individual and she believes that the Jeter's Leaders Program has helped her to achieve that. She credits the program for enabling her to be more outgoing, social and self-confident and also helping her to develop better communication and time management skills. She has a desire to join an intramural sport and also to work with a community service program. Ashley credits the Jeter's Leaders Program with providing her with important professional attributes. She has become more responsible, organized, outspoken and friendly and also improved her communication skills. When asked what part of the Program would help her most in the next phase of her life, Ashley stated, "The Program commitment because we had to make sure we follow the policy in order to remain in the Program." She added, "Applying and joining the Jeter's Leadership Program is one of the best things I have ever done for myself because it has exposed me to colleges, people and career options that I would not have known existed otherwise."

Having graduated Dr. Susan S. McKinney High School in Brooklyn, NY, as valedictorian of his class, David Squires has his sights set on a career in Computer Science. David was awarded the TORCH Scholarship from Northeastern University, where he will be attending in the fall. While in high school, David

He will be attending Northeastern University to pursue a career as a Programmer, IT Manager or Game Developer. David's favorite memory from the Jeter's Leaders Program was attending and presenting during the 2011 Jeter's Leaders Leadership Conference in Tampa, FL. Even though it was his first time presenting at a conference, he overcame the nervousness and presented what he thought were great workshops for his peers. The part of the Program David feels will help him the most in the next phase of his life is the alumni network that he will have access to, in order to help him with advice and guidance in college and with his career. "The Jeter's Leaders Program," David explains, "provides students like me with the tools necessary to pave the road to success."



FATIMATA SAM

Born and raised in Brooklyn, NY, Fatimata Sam graduated Leadership & Public Service High School in Manhattan with plans on continuing her education at Syracuse University, studying Pre-Med. While at college, she will participate in Syracuse University's Mentor/Mentee Alliance (SUMMA), a one-

to-one mentoring group between students from the school, and young, successful Syracuse University alumni who live and work in NYC. She is the recipient of a \$32,000 merit-based scholarship and the women in Banking Scholarship for \$5,000. Fatimata's life and career goals are to become a humanitarian, a gynecologist, an entrepreneur or a model and credits the Jeter's Leaders Program with helping her develop skills she would need to become successful in her future plans. She explains that along with learning beneficial skills that she can take on to college, she's also become more outgoing and confident in regards to public speaking and communicating. 






Finding Role Models
