






dugout seats: In Play










RULE #2: Ball in flight striking fair side of the Western Metal Supply Building, including yellow side of metal facing attached to

the corner of the building: Home Run










RULE #4: Fair bounding ball bouncing into the seating area of the fair side of the Western Metal Supply Building and back onto

the playing field: Out of Play











RULE #5: Ball in flight striking recessed batter's eye in left-center

field: Home Run










the playing field

Batted bounding ball or thrown ball: Out of Play












**RULE #7:** Ball in flight striking metal safety railing at the Right Field Porch and rebounding onto the playing field: **In Play** 







**RULE #8:** Ball in flight striking the top of the metal safety railing at the Right Field Porch and bounding into the stands: **Home Run** 











**RULE #9:** Ball in flight striking to the left of the vertical yellow line of the metal safety railing at the Right Field Porch above padding:

**Home Run** 







left of the yellow line: Home Run








RULE #11: <u>Ball in flight</u> striking plexiglass partition above yellow line of the metal safety railing at the Right Field Porch: **Home Run** 











RULE #12: Bounding ball striking plexiglass partition above yellow line of the metal safety railing at the Right Field Porch: Two Bases












**RULE #13:** Any ball, batted, thrown or otherwise striking the plexiglass partition above the metal safety railing and rebounding

onto the field: Dead Ball












