CHEER ON THE BLUE JAYSTM IN BOSTON CONTEST (the "Contest")

OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. SPONSOR: The sponsor of this Contest is S.C. Johnson and Son, Limited, 1 Webster Street, Brantford, Ontario, N3T 5A3 ("**Sponsor**").

2. ELIGIBILITY:

- (a) The Contest is open only to residents of Canada who are of age of legal majority in the province/territory in which they reside at the time of entry.

- (c) Sponsor and RBJBP shall have the right at any time to require proof of identity and/or eligibility to enter the Contest. Failure to provide such proof may result in disqualification. All personal and other information requested by and supplied for the purpose of the Contest must be truthful, complete, accurate and in no way misleading. Sponsor and RBJBP reserve the right, in their sole discretion, to disqualify any entrant should such an entrant at any stage supply untruthful, incomplete, inaccurate or misleading personal details and/or information.

3. HOW TO ENTER:

- (a) The Contest entry period (the "**Entry Period**") begins at 10:00 a.m. Eastern Time ("**ET**") on Friday, March 13, 2020 and ends at 4:59 p.m. ET on Tuesday, June 30, 2020.
- (b) <u>Limit of five (5) Entries (defined below) per person/email address per day during the Entry Period, up to a maximum limit of one hundred and twenty-seven (127) total Entries, regardless of the method of entry.</u>

For Entries made via bluejays.com, each unique Eligible Code (defined below) may be submitted in connection with this Contest only once and any subsequent Entry submitted during the Entry Period with the same Eligible Code will be void. For greater certainty, each Participating Product listed in Schedule "A" to these Official Rules has a unique Eligible Code and Participating Products of the same type will have the same Eligible Code. By way of illustration, all 142 gram "Off!® Deep Woods® Aerosol Insect Repellent – Deet Free" products will have the same Eligible Code, and a person who purchases more than one of such product may only enter the Contest via bluejays.com once during the Entry Period with the Eligible Code contained thereon.

- (c) There are two (2) ways to enter: (1) via bluejays.com by entering an Eligible Code (defined below) and (2) via email entry. No other method of entry will be accepted.

Limited information submitted by entrants on bluejays.com, such as email addresses of those entrants who have opted in to receive commercial electronic messages (such as emails) from Sponsor, or contact information that will be used to facilitate prize delivery may be provided to Sponsor, treated in accordance with Sponsor's Privacy Policy available at http://privacy.scjbrands.com/en-us, subject to the entrants' stated preferences from time to time. Online entrants may be given the option to

Sponsor's and RBJBP's treatment of information is subject to each entrant's stated preferences from time to time.

4. PRIZE DESCRIPTION:

One (1) eligible entrant will win one (1) prize consisting of:

- (a) Admission tickets for the winner and three (3) guests (collectively, the "**Prize Participants**") to attend the Team's regular season baseball games scheduled to be played in the Boston, Massachusetts, United States of America metropolitan area (the "**Destination**") on Tuesday, September 22, 2020 and Wednesday, September 23, 2020 (each, a "**Game**" and, collectively, the "**Games**"). For clarity, the prize includes a total of eight (8) admission tickets (four (4) admission tickets to each Game);
- (b) Round trip economy air transportation for the Prize Participants from the international airport within Canada closest to the winner's residence (as determined in the sole discretion of Sponsor) to the Destination, departing on Monday, September 21, 2020 and returning on Thursday, September 24, 2020, or on such other dates as may be determined by Sponsor (the "Airfare");
- (c) Two (2) hotel rooms (standard double occupancy) for three (3) nights in the Destination in a hotel and on dates to be determined by Sponsor (the "**Hotel**");
- (d) Return ground transportation (via a single vehicle) for the Prize Participants from the Destination airport to the Hotel (the "Ground Transportation");
- (e) Opportunity for the Prize Participants to participate in a picnic in the Destination at a time and location to be determined by the Sponsor and RBJBP (the "**Picnic**"). The Picnic will include lunch food items and non-alcoholic beverages;
- (f) Four (4) Team-branded "replica" jerseys;
- (g) Four (4) Team-branded "replica" baseball caps; and
- (h) CAD \$500 (total) in spending money (via cheque).

The total estimated retail value of the prize is CDN \$5,700. Actual retail value of the prize will depend on the winner's departure city (the estimated retail value of the Airfare is based on the departure city of Toronto). Any difference in value will not be awarded.

5. PRIZE CONDITIONS:

- (a) Notwithstanding anything to the contrary herein, the winner must be available to attend the Picnic and each Game. Should the winner be unable to attend either the Picnic or any Game, the prize will be forfeited in its entirety and may be awarded to an alternate winner in accordance with these Official Rules.

Sponsor reserves the right to substitute any stated prize (or portion thereof) with an alternate prize of comparable or greater value at its sole and absolute discretion, for whatever the reason. - (c) All prize details, including Airfare and Ground Transportation times, the location of the Hotel, the Game seat locations, and the exact nature and duration of the Picnic, will be determined in the sole discretion of Sponsor and/or RBJBP. Some restrictions may apply. If the winner is entitled to Airfare and Ground Transportation, travel arrangements must be made through Sponsor's agent on a carrier of Sponsor's choice and tickets will be subject to those terms and conditions specified by the ticket issuers. In addition, if the winner is entitled to Airfare and Ground Transportation, the Prize Participants must travel together on the same itinerary and are responsible for ensuring they have all necessary travel documents (e.g., valid passport). The applicable MLB Entities reserve the right to remove or to deny entry to any winner and/or guest who engages in a non-sportsmanlike or disruptive manner, or with intent to annoy, abuse, threaten or harass any other person at the Game, event or exhibition. The Released Parties (defined below) will not be responsible for acts of God, acts of terrorism, civil disturbances, work stoppages or any other natural disaster outside their control that may cause the cancellation or postponement of any Major League Baseball game, event or exhibition. Major League Baseball game, event and exhibition tickets awarded as part of the prize may not be resold or offered for resale or used for any commercial or promotional purpose whatsoever. Any such resale or commercial or promotional use may result in disqualification and prize forfeiture, and may invalidate the licence granted by the game, event or exhibition tickets.
- (e) Any and all additional costs and expenses associated with prize acceptance and use not specified herein as being provided including but not limited to travel and health insurance, transportation costs (including checked baggage fees, excess baggage fees, and transportation to and from the

Game), meals, gratuities and other expenses incurred by the winner (and any guests) in claiming, accepting and/or using the prize are the sole responsibility of the individual winner.

6. RANDOM DRAW: At approximately 10:00 a.m. ET on Tuesday, July 7, 2020 (the "**Draw Date**"), a RBJBP representative, or other person designated by RBJBP will select by random draw one (1) potential winner from among all eligible Entries received.

Odds of winning depend on the number of eligible Entries submitted by an entrant and the total number of eligible Entries received during the Entry Period.

- **7. NOTIFICATION**: The potential winner selected in accordance with the previous section will be notified as follows:
 - (a) If the Entry submitted by the potential winner was submitted via an Entry Form on bluejays.com, the potential winner will be contacted by a RBJBP representative by telephone at the telephone number indicated in his/her Entry Form to determine if he/she is eligible in the sole discretion of the RBJBP representative.
 - (b) If the Entry submitted by the potential winner was submitted via Entry Email, the potential winner will be contacted by a RBJBP representative by telephone at the telephone number indicated in his/her Entry Email to determine if he/she is eligible, in the sole discretion of the RBJBP representative.

In the event that any potential winner does not respond to such notification within four (4) business days, incorrectly answers the skill testing question (described in more detail below), as determined by Sponsor or RBJBP in its sole discretion or declines a prize for any reason, he/she will be disqualified, the prize will be forfeited and, at Sponsor's discretion and time permitting, an alternate potential winner may be randomly selected from among all remaining eligible Entries.
