





This is something I've witnessed, time and time again, in the 22 years since the Turn 2 Foundation was established.

Turn 2 was born from an idea Derek and our father had to motivate young people to rise above negative influences and lead healthy, successful lives. The discussion they shared in 1996 led to a myriad of national youth leadership conferences and community service initiatives; leadership programs that have helped thousands of youth graduate high school and fulfill their ambitions in college; more than \$29 million donated from our Foundation to organizations that support our mission, and beyond.

Over the years, our incredible network of supporters, partners, volunteers, donors, staff and friends have joined forces to build upon Turn 2's legacy and make a positive difference in the lives of so many young people. And because of that, we have been able to move the needle, and inspire the youth we serve to work collectively to use their voices – and their actions – to ignite social change across the country.

The milestones we've accomplished in the last year alone demonstrate the tremendous success we have been able to achieve together.

From our hurricane relief efforts with our friends Jorge and Laura Posada, to the Jeter's Leaders service project in Miami and more, our Foundation collectively completed 1,897 hours of community service initiatives in the last year, serving more than 2,000 individuals across the country.

In April, some of the biggest names in sports and entertainment came together for the fourth annual Derek Jeter Celebrity Invitational, which contributed more than \$1 million to the Turn 2 Foundation. Since its inception, this outstanding event has contributed more than \$4 million to Turn 2 – and these critical funds enable us to continue to take our programs to new heights each year.

We welcomed our newest class of Jeter's Leaders in New York and Kalamazoo in June, as we celebrated the graduating class of 2018. And for the 13th consecutive year, 100% of our seniors graduated high school and went on to attend college. This is a remarkable achievement, and I am so proud of these students!

Additionally, this year Turn 2 awarded \$70,000 in college scholarships to these bright high school seniors. And in total, the 2018 graduating class earned more than \$1.2 million in scholarships for their four years at college. Academic excellence is a cornerstone of our Foundation, and we are proud to provide support to our Jeter's Leaders to help further their education.

These are just a few of the important milestones that have taken place since our last Annual Dinner, and as you turn the page, you will read more about our story. As friends of Turn 2, I hope you feel a sense of pride when you learn how your continued support has played a critical role in the success and growth of the Foundation, and the impact we've been able to have on the young people we serve.

I am incredibly excited for the future of the Turn 2 Foundation, and I know that together, we will be able to make a positive, long-lasting difference in this world.

## Turn 2 Honors DeDe Agar-Lawrence & Ron Cortina of Goldman Sachs with 2018 MVP Award

ust one week after her high school graduation in 1984, DeDe Agar-Lawrence hopped on a bus from Keansburg, New Jersey to New York City to knock on doors with the hopes of earning a summer job. Through her networking, the determined 17-year-old landed an assistant role at Goldman Sachs. While attending evening classes, she worked her way up to vice president at the global investment banking firm, where she has now worked for 34 years.

Ron Cortina, whose parents immigrated from Italy and settled in the Bronx, was the first in his family to attend college in the United States. A driven young man, he graduated from Pace University and earned his MBA at the University of Chicago. He began his career at

PwC and later joined Goldman Sachs, where he has worked for 21 years and currently serves as managing director.

While their journeys were different, DeDe and Ron both surmounted obstacles to get to where they are today, and thank their mentors for teaching them important values that helped them grow professionally and personally. So when an opportunity arose to do the same for high school students in need of guidance, they didn't hesitate.

Dr. Charles Jeter introduced Ron to Turn 2 in 2001. Ron quickly recognized the common values of mentoring and leadership shared between Goldman Sachs and the Foundation, and it was immediately evident that this was the beginning of a special partnership.

"There is a very strong connection between the values and culture at Goldman Sachs and the Turn 2 Foundation's mission: it's all about providing mentorship and strategic direction," said Ron. ## MIAMI MIDDLE SCHOOL TRANSFORMED BY THE POSITIVE POWER OF SOCIAL CHANGE

ome of Miami's most consequential pieces of street art are on display in an unexpected location – Jose de Diego Middle School, where more than 500 local students attend every day.

In April, a group of powerhouse volunteers – including Derek, Hannah and Sharlee Jeter; more than 100 students from the Jeter's Leaders program; volunteers from HandsOn Miami; and members of Goldman Sachs Community TeamWorks – made their mark on this living canvas and spread their message of positive social change.

"A core component of the Jeter's Leaders program is teaching youth the importance of giving back and empowering others to follow suit," said Sharlee. "This initiative provided our Jeter's Leaders with a unique opportunity to venture outside of their communities and share the fundamental Turn 2 values with other young people."

Throughout the day, the volunteers worked together to beautify the school by creating artistic and inspirational murals. The murals – which included words of kindness, healthy-eating messages, garden imagery, a STEM mural in the engineering

classroom and more – were intended to inspire youth to lead healthy lifestyles, focus on their education, and work hard to accomplish their goals.

They also incorporated important improvements to the middle school, and repainted pots to match the school's new, artistic atmosphere; repotted plants; repainted stairways; built benches; and repainted the basketball court.

"Jose de Diego Middle School is a campus adorned with 86 murals on both the interior and exterior of its building. This project with the Turn 2 Foundation allows our students to not only expand their artistic minds, but also deepen their understanding of community service," said April Thompson, principal of Jose de Diego Middle School.





Later in the day, the volunteers embarked on a tour of the school, where they learned about the existing murals displayed on campus and the notable artists who created them. The Turn 2 Foundation also presented a \$10,000 donation to the school to support renovation and recovery from recent hurricanes, and to help provide a better learning environment for the students.

Turn 2 coordinated the community service project with HandsOn Miami, an organization committed to inspiring, equipping and mobilizing people to take action to effect positive change in the Miami-Dade County community. The Turn 2 Foundation has worked with HandsOn in the past at its 2010 and 2017 Social Change projects in New Orleans, as well as in Chicago in 2013 and Washington D.C. in 2012. The project was



## Turn 2 Us Celebrates 16 Years of Fostering Mental Wellness

For decades, the concept of mental health was encumbered by the stigma associated with little-understood illnesses. It was a subject few wanted to talk about, let alone confront. Over the last 30 years, however, attitudes have shifted, bringing mental health out of the shadows at last. As time and resources were dedicated to understanding mental health, it became apparent that it is not simply something to treat, but to nurture proactively beginning at an early age.

Today, we know that when we foster mental wellness in children, they are more likely to excel in their academics, attend college and ultimately succeed in their personal and professional endeavors; it is a positive cycle that leads young people on paths to healthy, promising futures. One initiative pioneered 16 years ago in New York City – *Turn 2 Us* – is a testament to the sort of profound impact such an approach can have, helping thousands of young people improve their mental well-being during that time by diving into the most important setting for early recognition: the classroom.



As a foundation rooted in fostering healthy lifestyles, the Turn 2 Foundation created *Turn 2 Us* in 2001 as a collaborative effort with Public School 128M of Washington Heights and NewYork-Presbyterian Hospital. The elementary school-based program, which promotes positive mental well-being among young people, expanded in 2007 to include Public School 4M and currently serves 1,700 students. Since its inception, *Turn 2 Us* has provided a comprehensive range of services to students, school staff, parents and caregivers, before, during and after school hours, reaching more than 10,000 people in New York City.

"Early proactive intervention is a powerful tool for promoting healthy, long-term outcomes, and dramatically increases a young person's likelihood of improving their mental health," said *Turn 2 Us* program manager Evelyn Montañez Ph.D., R-LCSW. "With schools serving as a primary setting for early intervention, it is important for us to bring this conversation to the classroom and equip educators with the tools they need to provide support to students."

School staff play an integral role in ensuring mental health education programs are introduced to people at a young age. Through its Mental Health Literacy program, *Turn 2 Us* provides staff development workshops that are tailored to all teachers, administrators, cafeteria aids and other staff, and covers a wide range of topics including classroom tactics and self-care strategies.

"Health isn't just about physical wellbeing, and I think that is too easy to forget," said Sharlee Jeter. "Positive mental well-being is a huge part of leading a healthy lifestyle, and it's absolutely crucial for us to dive into classrooms and address the importance of mental health directly with students, teachers and parents."

In the classroom, *Turn 2 Us* provides programming for all students through a holistic approach to achieving mental wellness, from mindfulness exercises, to anti-bullying education, to healthy lifestyle practices that promote wellbeing and academic success.

For children who could benefit from additional support, *Turn 2 Us* offers 12-week social-emotional development skills-building groups known as intervention tracks, facilitated by program staff during recess. Teachers who receive mental health training at the beginning of the academic year can

refer students by completing a standardized *Turn 2 Us* Student Activities Referral Form. The program staff and the school's Child Study Team – consisting of the guidance counselor, special education team, on-site mental health providers and the dean or school administrators – determine if students should be introduced to the program.

Children who present predominately internalizing behaviors are invited to participate in a 12-week creative arts or drama track, and students who exhibit externalizing behaviors are invited to join either the Basketball or Baseball Healthy Lifestyles League, which is offered across eight elementary schools.

"Through the *Turn 2 Us* program, we have been able to provide critical resources to help our students work through challenges and ultimately achieve mental wellness. And countless young people are better off because of this initiative," said Principal Washington Hernandez, of PS8 in Washington Heights.

While *Turn 2 Us* works to transform mental health education and treatment in schools, the program also stresses the importance of increasing awareness in households. Through workshops designed specifically for parents and caregivers, *Turn 2 Us* focuses on several topics, including symptoms, treatment, de-stigmatizing mental health issues, effective stress management tools and discipline strategies.

"Helping young people reach their full potential begins with leading healthy lifestyles, and mental wellness is a critical component of that," said Derek Jeter. "The *Turn 2 Us* program helps position children to succeed and empowers their teachers and families to support them along the way. I am so proud of the incredible results this initiative has achieved over the last 16 years, and I know we will be able to positively impact the lives of more young people well into the future."

In October of 2017, Derek and the Turn 2 Foundation were honored for their 16-year partnership with NewYork-Presbyterian in Washington Heights. School administrators, students and their parents joined Derek, Sharlee, Dr. Charles and Mrs. Dorothy Jeter, NewYork-Presbyterian executive vice president and chief operating officer Dr. Laura L. Forese and Dr. Evelyn Montañez in a special ceremony to celebrate the anniversary.

"For 16 years, we have been able to change the way that educators, parents and young people view mental health," added Sharlee. "The impact has been tremendous, and we are excited to do more." ■



#### The Jeters and Posadas Partner Off the Field to Support Puerto Rico Hurricane Relief Efforts



ollowing the devastating impact of Hurricane Irma and Hurricane Maria in Florida and Puerto Rico, Derek and Sharlee Jeter joined forces with Jorge and Laura Posada to help provide relief and aide to the thousands of individuals who were impacted by the disasters.

remarkable example on how to be a good citizen."



## ALEXANDER PENA Fairleigh Dickinson University



or each class of Jeter's Leaders, graduation day is a momentous occasion that not only celebrates their futures, but also represents the tireless work that went into pursuing their dreams and their dogged determination to overcome adversity. Every year, as the graduating Jeter's Leaders proudly accept their diplomas and move onto their next chapters in college, Turn 2 president Sharlee Jeter is reminded of someone who similarly surmounted major obstacles to fulfill her goals – her younger self.

For Sharlee, walking across the graduation stage at Spelman College signified her personal victory of overcoming Hodgkin's lymphoma, while simultaneously earning her degree in mathematics – and never missing a beat. Sharlee's persistence,



inner fortitude, commitment and tremendous support system were key factors in her ability to prevail. These are lessons she has imparted on thousands of young people through the Turn 2 Foundation, and that she is sharing now with individuals around the world through her new book, *The Stuff*, which launched in May.



Sharlee's 22 years of work with the Foundation – starting as a high school volunteer and working her way up to president in 2010 – served as a catalyst for the book, inspiring several philosophies that are featured throughout *The Stuff*. The young people, volunteers and other individuals who have come through the Foundation's doors – combined with Sharlee's personal experience conquering obstacles – motivated her to write a book that would inspire countless others around the world to realize their own potential.

The Stuff is co-authored by Sharlee and Dr. Sampson Davis, emergency room physician, public speaker, New York Times bestselling author of The Pact, and co-founder of The Three Doctors Foundation, and is published by Jeter Publishing and Gallery Books. Through the lens of more than two dozen inspiring stories – including Sharlee's and that of Dr. Sampson Davis – The Stuff highlights 11 core elements that help individuals thrive in spite of life's challenges. The book also features the Jeter's Leaders initiative as a model, demonstrating that all individuals have the ability to succeed in life. Additionally, a team of past and present Foundation consultants comprised of psychologists and social workers, including Dr. Charles Jeter, assisted the authors with the research and findings in The Stuff! ■

Friday morning marked the final round of the Celebrity-Amateur tournament, with former NFL star Sterling Sharpe and his team emerging with the win.







rowing up, Luis Morales witnessed the positive effects that a well-trained and caring rehabilitation therapist can have on a patient – in his case, his own sister. After that personal experience sparked his interest in the field, Luis realized his true passion for helping others through occupational therapy while serving as an intern at Bronson Healthcare. When Luis began his internship at Bronson in 2015, he didn't imagine his experience there would have an impact far beyond that summer, ultimately helping him choose a career path.

# JETER'S LEADER PURSUES HIS PASSION AT Bronson Healthcare

Despite feeling timid at the start of his intern program, Luis quickly became comfortable at Bronson as he continued to shadow the therapists and form professional relationships with the patients. Luis' respectful attitude, upbeat demeanor and consistent positivity led his managers to ask Luis to return for two additional summers. During his subsequent internships at Bronson, Luis continued to demonstrate reliability, attention to detail and a strong work ethic. Luis was eventually offered a position as a rehab clinical assistant, where he works alongside physical and occupational therapists assisting with patient care and gaining first-hand experience into their day-to-day jobs.

"We are committed to building the next generation of the workforce and acquainting youth with the full spectrum of healthcare careers, exposing them to more options than simply doctors and nurses," said Kimberly Barr, security coordinator at Bronson and member of the Turn 2 Resource Council. "One of Bronson's core values is building trusting partnerships, and our relationship with the Turn 2 Foundation and the Jeter's Leaders program over the past eight years has allowed us to do just that. We look forward to continuing to welcome Jeter's Leaders as interns, and hopefully as full-time Bronson employees."

After gaining further insight into hands-on rehabilitative work, Luis decided to change course from pursuing physical therapy – his initial interest area – and major in occupational therapy at Western Michigan University, where he plans to graduate with a bachelor's and master's degree in 2021. He credits much of his success in school to the preparation he received during his internship, including learning occupational therapy terms and building key relationships.

"My sister has autism, and while she was growing up I often attended her occupational therapy sessions. I noticed that the therapists treated my sister like a regular person rather than an outsider," reflected Luis. "My passion for OT grew during my internship at Bronson as I was able to become that person for someone else, helping those kids in their everyday life like other therapists did for my sister."






remains very connected to the Jeter's Leaders program, attending events and staying in close contact with individuals he says have helped him become who he is today.

# NEXT STOP FOR THE JETER'S LEADERS:

Uring their four years as youth ambassadors for Derek Jeter, members of the Jeter's Leaders program work together to spearhead national youth leadership conferences, execute community service initiatives and use their voices to create positive social change – all while navigating the often daunting challenges of high school. From the start, the Turn 2 Foundation has been there to support these teenagers in tackling one of the most important decisions they will ever make: where to attend college.

To prepare for this next chapter, the Turn 2 Foundation each year introduces its Jeter's Leaders to a number of colleges and universities, where they venture outside their New York City and West Michigan communities and immerse themselves in college life. The annual College Tours are part of a larger initiative that includes resume building, public speaking, internship opportunities and beyond, providing high school students with the tools they need to succeed in their academic and professional careers.

By fostering academic excellence, social change, healthy lifestyles and leadership development, the Foundation's signature initiative has helped 100% of its Jeter's Leaders graduate high school and attend college for the past 13 years. Graduates of the program have attended more than 75 colleges across the country, from Ivy Leagues, to Historically Black Colleges and Universities, to acclaimed state universities and leading research institutions.

This year's College Tour included stops to 15 colleges and universities across the country. At each visit, the Jeter's Leaders toured the campuses, learned about course offerings and degree programs, and spoke with current students and faculty about college life, while representing Turn 2 and its core values. The Kalamazoo Jeter's Leaders kicked off their leg of the College Tour in February with visits to Roosevelt University, DePaul University, and the University of Chicago. Later that month, the New York Jeter's Leaders made stops to American University, Georgetown University, Howard University, Loyola University, Coppin State University, and the University of Maryland.

In April, the Jeter's Leaders ventured to South Florida for the 2018 service project, where they worked together to spread positive social change and beautify Jose de Diego Middle School in Miami. Following the impactful community service initiative, more than 100 of the Jeter's Leaders visited a number of the area universities, including Florida Memorial University, University of Miami, Barry University, Florida Atlantic University, St. Thomas University, and Florida International University.

"This program helped me realize that there are endless opportunities for my future," said Jackson Henning, Kalamazoo Jeter's Leader, class of 2018. "I'm really excited for this next chapter."

The campus tours are designed to inspire the Jeter's Leaders to pursue higher education and begin envisioning their own college journey as the next step toward fulfilling their goals. And more than 20 years after Turn 2 began, the results speak for themselves.

What's next for these promising students as they continue to build a foundation for a successful future? The sky is the limit.

# Tampa Children Knock It Out of the Park at 11th Annual Baseball Clinic

s baseball's biggest stars - from Mike Trout to Bryce Harper to Manny Machado - geared up for the 2018 season during spring training, hundreds of young ballplayers were drawing cheers of their own nearby at the Port Tampa Community Center. The Turn 2 Foundation had returned for its 11th annual Tampa Baseball Clinic – an event that has welcomed more than 1,000 children from the community throughout its 11-year run.

During the free, four-day program, local coaches taught participants throwing, hitting, running, catching and fielding


