### **USA BASEBALL X GIVEAWAY**

**OFFICIAL RULES – NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE YOUR CHANCES OF WINNING. OPEN TO LEGAL RESIDENTS OF THE 50 UNITED STATES AND D.C., 18 YEARS OF AGE OR OLDER AND LEGAL AGE OF MAJORITY IN APPLICABLE JURISDICTION. VOID WHERE PROHIBITED.**

**1. How to Enter:** Beginning at 9:00 a.m. Eastern Time (“ET”) on Friday, March 28 2025 until 11:59:00 p.m. ET on Sunday, March 30 2025 (the “Promotion Period”), you may enter the USA Baseball X Giveaway (the “Promotion”) by following the steps details below. All entries must be received by the end time and date of the Promotion Period to be valid and eligible. Incorrect and incomplete entries are void. These official rules are also available on the USA Baseball website ([www.usabaseball.com/about/sweepstakes](http://www.usabaseball.com/about/sweepstakes)) (the “Website”).

To enter you will need to sign into your X account (“X Account”) or, if you are not already a member, become a member of X.com and sign into your X Account (“X Account”). Creating an X Account is free. By submitting your information and creating an X Account, you will be required to agree to the X terms of service and privacy policy. After you have an X Account, to enter the Promotion, during the Promotion Period, submit your entry by: (i) following @USABaseball and (ii) quote-tweeting the post from @USABaseball that advertises this Promotion (the “Prompt Post”). The Prompt Post will include the hashtag: “#Sweepstakes”.

If your X Account is set to “protected mode” or “private”, your updates/responses may not be visible to Sponsor and, therefore, will not be received by Sponsor, resulting in your failure to enter the Promotion. Sponsor may not receive entries that fail to strictly follow the posting instructions set forth in these Official Rules and Sponsor is not responsible for failure to see or receive an entry. Sponsor, at its sole discretion, may accept a technically incorrect unique term. Messages not received by Sponsor will not be entered into the Promotion.

During the Promotion Period, there is a limit of one (1) entry per eligible person. If multiple entries are received, all entries from that participant will be disqualified. Multiple participants are not permitted to share the same X account. Any attempt by you to obtain more than one (1) entry by using multiple/different email addresses, X Accounts, identities, registrations or logins, or any other methods may void your entries and you may be disqualified from the Promotion. Any use of robotic, repetitive, automatic, programmed or similar entry methods or agents (including, but not limited to, sweepstakes entry services) will void all entries by you.
