WINNING. OPEN TO LEGAL RESIDENTS OF THE 50 UNITED STATES AND D.C.,  
18 YEARS OF AGE OR OLDER AND LEGAL AGE OF MAJORITY IN APPLICABLE  
JURISDICTION. VOID WHERE PROHIBITED.**

**1. How to Enter:** Beginning at 7:00 p.m. Eastern Time (“ET”) on Monday, September 29, 2025 until 8:00 p.m. ET through Friday, October 3, 2025 (the “Promotion Period”), you may enter the USA Baseball Week Of Giving: Power Hour Giveaway (the “Promotion”) offered by United States Baseball Federation dba USA Baseball (the “Sponsor”). Incorrect and incomplete entries are void. These official rules are also available on the USA Baseball website ([www.usabaseball.com/about/giveaways](http://www.usabaseball.com/about/giveaways)) (the “Website”).

**2. No Purchase or Donation is Necessary to Enter or Win.** There are two ways to enter. First, the first 12 donors each day during the to the USA Baseball Week of Giving who pledge a minimum of \$100 USD and pledge within the “Power Hour” will be entered. These “Power Hours” will take place a 7:00 p.m. Eastern Time on Monday, September 29, 2025 through Friday, October 3, 2025. Second, the first 12 individuals who provide their email address to [drakesacenti@usabaseball.com](mailto:drakesacenti@usabaseball.com) within the Power Hour will also receive one entry. Only one entry per person, per Power Hour each day is permitted.

**3. Sponsor may not receive entries that fail to strictly follow the instructions set forth in these Official Rules and Sponsor is not responsible for failure to see or receive an entry. Entries not made in compliance with one of the two methods of entry will not be entered into the Promotion.**

During the Promotion Period, there is a limit of one (1) entry per eligible person. Any attempt to obtain more than one (1) entry by using multiple/different email addresses, identities, registrations or logins, or any other methods may void entries and cause disqualification from the Promotion. Any use of robotic, repetitive, automatic, programmed or similar entry methods or agents (including, but not limited to, sweepstakes entry services) will void all entries made via these methods. In the event of a dispute as to any online entry, the authorized account holder of the email address associated with an Account used to enter will be deemed to be the entrant.
